 - Given all of the events in the past year, there is window of opportunity to have all the chancellors focus on working together before it's back to business as usual.

 - Grad School expects to be OK because it doesn't have as much state funding at stake.
- New HR System, any Grad School expectations? (Converse)
 - Simple as possible, but no simpler.
- New updates on rehired annuitant legislation? (Hackel)
 - The recall efforts for now seem to have halted these for the time being.
