Introduction

Dear L&S chairs, directors, faculty, and academic program staff:

Annual assessment reports are due to the college by May 15, 2013.

By completing the survey that follows, you will be submitting your annual report on the assessment of student learning. These reports are needed so UW-Madison can comply with Regent and Federal regulations that require the university to systematically perform this work for all academic programs that lead to a credential (degree, major, and certificate). Your responses will be used to create the L&S Annual Report to the Provost on the Assessment of Student Learning. The college report to the Provost must contain a response for every L&S credential. As you know, this is a huge task - your help is essential.

You may also notice that the information you provide here will be requested by other entities - the L&S Academic Planning Council, Curriculum Committee, and other groups in the college refer to assessment activities when discussing program reviews, requests for changes to courses and curricula, requests for departmental reconfiguration, calls for proposals for new projects, etc. Understanding how, and how well, our students are performing in our programs is essential to the work we do. The responses you provide will help us know if we're headed in the right direction.

We do not currently have an assessment plan on file. The Center for European Studies does undergo regular assessment through Title VI applications (most recently in 2010 for the 2010-14 Title VI grant) and bi-annual Title VI reporting (October and April), also through site visit reviews and feasibility studies. CES also participated in a major alumni survey conducted in 2011-12 as part of the Standardized Wisconsin Evaluation Plan for Title VI (SWEPT) prepared for and submitted to UW's International Institute and Title-VI Funded National Resource Centers by Theodore P. Gerber Professor of Sociology and Director of the Title VI Evaluation for the International Institute. The Survey report was published in March 2012.

CES has undergone several program assessments in recent years. The SWEPT survey (2012, see above Q4.1) included 189 European Studies alumni respondents. A recent survey of all Certificate Alumni (1000 + former students) has just been completed and is intended primarily as part of a feasibility study for future graduate level offerings (Results are pending). European Studies has also been assessed by external reviewers on several occasions (most recently 2009) as part of the European Union Center of Excellence review.

While CES does not yet have an assessment plan of the type requested, the SWEPT survey gave valuable information on how former students viewed the Center's involvement with students, and the support these students received in developing their interests in Europe. Useful data was also gained from the survey about issues related to the visibility of the Center on campus, student awareness of CES programming and the Certificate, and the level of staff and faculty support given to students.

Key findings as related to undergraduate and graduate students can be summarized by survey responses from the SWEPT comments field. Results indicate that CES needs to find new ways to increase its visibility on campus – especially among undergraduate students with related interests, and then develop strategies to encourage students to declare the Certificate earlier on in their academic careers. While Certificate enhancements/redesign may not be needed (the Certificate is robust requiring 21 credits of area studies courses, demonstration of interdisciplinarity, breadth and depth of knowledge of Europe and European countries, and competency in at least one European language), greater emphasis needs to be placed on bringing students into European Studies earlier – both to declare the Certificate and then through the listserve to be more aware of the wide variety of European on-campus events, and to take advantage of opportunities and support offered to students through CES.
