Academic Program Matters (a) Adjustments to Guide Information for Graduate Programs (i) Change from "admitting" to non-admitting status for MA/MS programs (ii) GRE scores required for admission to Graduate programs (sample request: PhD Second Language Acquisition) In conversation, members noted that studies and data about using GRE scores could be very helpful for informing department and school/college conversations. They also noted that that recruitment, curricular, and retention plans are very important for creating a diverse pool of students. Changing GRE requirements is only one part of a strategy, but can't be the only part. Members recommended that departments describe the alternate way they will be evaluating applicants in Lumen Program proposals that request this change. They also recommended the Work with graduate program to get whatever data or analysis they have available so departments can use them.

and the opportunities that is already creating; wrapping up the fundraising campaign which has been very successful.
