UW System Regent policy on English language proficiency has been clarified. UAPC: ESL118 represents UW-Madison English language proficiency standard, distinct from Comm A. 9	Timing of enrollment in ESL courses	Enrollment for continuing students was delayed until end of semester to prevent misenrollment if students didn't pass. This led to problems for students setting schedules, and for the program planning course offerings.	Students in ESL courses may enroll at regularly assigned enrollment time; requisites (based on courses and test scores, not student groups) for ESL courses will be enforced; PERC will be used to un-enroll students who did not pass pre-req course or who do not have appropriate placement test score.
10	Incomplete information shared about student progress	Only initial placement test score available; no further information provided about progress through sequence.	Students in ESL courses are re-tested at beginning and end of term. End-of-term results to be posted in SIS and represented in DARS as additional MSN-ESLAT test scores. Students who are re-placed at beginning of term will be allowed to enroll in new course by permission of instructor.
